The name of the University has been included in the list of Universities established as per Section 2 (f) of the UGC Act, 1956.

Sir,

With reference of your letter No. AdtU/RO/UGC-COM/2016/01/113 dated 04.06.2016 on the above subject, I am directed to inform you that Assam Down Town University, Guwahati, Assam has been established by an Act of State Legislature of Assam as a Private University and is empowered to award degrees as specified under Section 22 of the UGC Act through its main campus in regular mode with the approval of Statutory Bodies/Councils, wherever its required.

Assam Down Town University, Guwahati, Assam is not authorized to open study centre/ off campus centre beyond the territorial jurisdiction of the state as per the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal Vs. State of Chhattisgarh. The University can not open its centre(s) even within the state as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC.

The UGC has not granted any approval to the University to open off campus/study centre.

Sir,

This has reference to the proposal submitted by the University for 12-B status and subsequent visit of the UGC Expert Committee on 12<sup>th</sup> & 13<sup>th</sup> March, 2020 to consider the proposal. The Report of the Expert Committee alongwith the compliance submitted by the University was placed before the Standing Committee of UGC members for consideration. The Committee recommended as under:-

**"The Committee considered the report of the UGC's Expert Committee along with the compliance submitted by the University.**


**The Committee decided to recommend approval of 12 B status to Assam Down Town University, Sankar Madhab Path, Gandhi Nagar, Panikhaiti, Guwahati (Private University) subject to the condition that the financial assistance under all UGC schemes shall be limited to those relating to teachers and students only.**

**The University is advised to participate in NIRF ranking and get NAAC accreditation at the earliest and to ensure that the faculty sanctioned and in position should be as per concerned statutory council(s)/ UGC norms in all the Departments."**

The above recommendations of the Committee along with the Report of the UGC Expert Committee were placed before the Commission in its 553<sup>rd</sup> meeting {item No.1.02(a)(iii)} held on 26<sup>th</sup> October, 2021. The Commission has ratified the recommendations of the Committee.

The name of University has been included in the list of universities under Section 12(B) of the UGC Act, 1956.
