#### **Anti-Ragging Policy**

# **Policy Statement:**

The mission of the Anti-Ragging Standard Policy at Assam down town University is to create a safe and conducive learning environment that promotes respect, dignity, and well-being for all students. The policy aims to prevent and eradicate ragging activities, ensuring a harmonious atmosphere that fosters academic growth and personal development.

# Objectives:

- 1. To prohibit and prevent any form of ragging within the university campus or at any affiliated institution.
- 2. To raise awareness among students about the detrimental effects of ragging and its consequences.
- 3. To provide a mechanism for reporting incidents of ragging and ensuring appropriate action is taken.
- 4. To establish a support system for victims of ragging and ensure their safety and wellbeing.
- 5. To promote a culture of mutual respect, inclusivity, and empathy among the university community.

#### **Functions:**

- 1. Formulating and reviewing the Anti-Ragging Policy as per statutory requirements and guidelines.
- 2. Conducting regular awareness programs, workshops, and campaigns to educate students about the consequences of ragging.
- 3. Implementing preventive measures such as surveillance, monitoring, and supervision in hostels, common areas, and campus premises.
- 4. Establishing an Anti-Ragging Committee and Anti-Ragging Squads to respond promptly to reported incidents.
- 5. Conducting inquiries and investigations into reported cases of ragging and taking appropriate disciplinary action against the perpetrators.
- 6. Providing support, counselling, and rehabilitation measures for victims of ragging.
- 7. Coordinating with the Directorate of Student Welfare and the Warden to ensure effective implementation of the policy.



#### Roles and Responsibilities of the Anti-Ragging Committee Members:

## Chairperson:

- 1. Provide overall leadership and guidance to the Anti-Ragging Committee.
- 2. Chair committee meetings, set the agenda, and ensure effective communication and collaboration among members.
- 3. Coordinate with relevant stakeholders and authorities regarding anti-ragging initiatives and actions.
- 4. Oversee the implementation of anti-ragging policies and procedures within the institution.
- 5. Maintain records of discussions, decisions, and actions taken by the committee.

# Member (Administrative staff):

- 1. Assist in the development and implementation of anti-ragging policies, procedures, and awareness campaigns.
- 2. Monitor and evaluate the effectiveness of existing anti-ragging measures and propose improvements as necessary.
- 3. Collaborate with other committee members to investigate reported ragging incidents.
- 4. Coordinate with administrative departments to ensure compliance with institutional policies.
- 5. Maintain confidentiality and handle sensitive information professionally.

#### Member (Academic staff):

- 1. Promote a safe and inclusive learning environment, free from ragging, through educational initiatives.
- 2. Contribute to the planning and delivery of anti-ragging awareness programs and workshops.
- 3. Encourage students to report ragging incidents and support them in the reporting process.
- 4. Collaborate with the committee in investigating reported incidents and implementing appropriate actions.
- 5. Provide guidance and counselling to students affected by ragging incidents.

#### Legal Officer:

- 1. Advice the committee on legal aspects related to anti-ragging policies and actions.
- 2. Ensure that the committee's activities align with relevant laws, regulations, and guidelines.
- 3. Provide guidance in conducting investigations, maintaining legal compliance, and addressing legal issues.
- 4. Assist in the review and drafting of institutional policies related to ragging prevention and response.
- 5. Collaborate with external legal authorities, if necessary, in cases of serious ragging incidents.

#### Member (Warden, Boys Hostel):

- 1. Ensure a safe and secure environment within the boys' hostel, actively preventing and addressing ragging incidents.
- 2. Enforce hostel rules and regulations that prohibit ragging.

- 3. Conduct regular inspections to identify potential ragging activities or unsafe situations.
- 4. Collaborate with the committee to investigate reported ragging incidents within the boys' hostel.
- 5. Provide support and necessary services to victims and implement disciplinary measures as per institutional policies.

# Member (Warden, Girls Hostel):

- 1. Ensure a safe and secure environment within the girls' hostel, actively preventing and addressing ragging incidents.
- 2. Enforce hostel rules and regulations that prohibit ragging.
- 3. Conduct regular inspections to identify potential ragging activities or unsafe situations.
- 4. Collaborate with the committee to investigate reported ragging incidents within the girls' hostel.
- 5. Provide support and necessary services to victims and implement disciplinary measures as per institutional policies.

#### Student Counsellor:

- 1. Provide confidential counselling services to students affected by ragging incidents.
- 2. Conduct individual or group counselling sessions to support victims and help them cope with the emotional and psychological impact of ragging.
- 3. Collaborate with other committee members to develop and deliver awareness programs and workshops.
- 4. Act as a bridge between students and the committee, providing regular updates on counselling interventions and student well-being.

#### External Member:

- 1. Bring external expertise, perspective, and accountability to the committee.
- 2. Participate actively in committee meetings, discussions, and decision-making processes.
- 3. Assist in policy review and development, ensuring alignment with best practices and legal requirements.
- 4. Conduct periodic reviews and assessments of the institution's anti-ragging initiatives.
- 5. Provide recommendations and feedback for continuous improvement in ragging prevention and response strategies.

### Frequency:

The Anti-Ragging Committee will meet as and when necessary, depending on the nature and severity of reported incidents or for policy review and updates.

#### **Contact for Students:**

Students can contact the Warden or the Directorate of Student Welfare for any concerns, incidents, or to seek assistance related to ragging.
