ELIGIBILITY CRITERIA FOR ADMISSION TO Ph.D PROGRAMME:

Eligibility Criteria for Admission to Ph.D Programme:

Candidates who have completed:

• A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the

educational institution. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

• Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale, wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time. However, such candidates will only be allowed under the full time Ph.D Program of the University.

AdtU-RET:

AdtU-RET examination has the following two components:

- Written test [70marks]
- Interview/Personal Interaction [30 marks]

Components of PhD-RET Written Examination:

Interview/Personal interaction: Students who have secured 50% marks in the written test will be eligible for the interview.

Exemption from Entrance test:

- The candidates who have qualified for fellowship/scholarship in UGC-NET/UGC-CSIR NET/GATE/ GPAT/CEED and similar National level tests based on an interview in the concerned subject are exempted from the written examination of AdtU-RET. However, they shall have to appear in interview/personal interaction for getting admission into the program.
- NET qualified candidates are exempted from written examination.NET score obtained by the candidates in NET examination will be utilized for PhD admission as per UGC guidelines. However, such candidates shall have to appear in interview /personal interaction for getting admission into the programme.

Concept Note and PPT:

• All the selected applicants need to submit a concept note on their research interest/area
